Rent agreement for Consensus Car Financial year 2021 – 2022

RENT AGREEMENT FOR CONSENSUS CAR

1.1	The agreement is established between Consensus – the student union at the faculty of Medicine and Health Sciences orgnr. 8220003-1564 and hereinafter							
	referred to as the rentee. The rentee must be a person holding a driving license with authorization B or higher or equivalent to and being a union member.							
1.2	The rentee has right to use the vehicle from (date and time:, to (date and time):, to							
2.	RESPONSIBILITY AND RIGHTS							
2.1	1 If the car is damaged or for some other reason can't be available for the rentee, for example, Consensus needs the car in emergency case or on short notice, shall Consensus contact the rentee as soon as possible. Consensus has no responsibility for replacing the vehicle and the booking is deleted.							
2.2	The rentee shall return the keys and driver's log to Consensus no later than (date and time):							
2.3	The driving log must fill in the driver's name, date, the trip meter indication, and fuel meters before departure and after return, the length of the trip in meters, and the rentees signature. The driver's log shall return together with the keys. If this is not done, Consensus undertakes the right to invoice the rentee for other costs that may arise as a result.							

- 2.4 The price for renting the car is **100kr per 2hour period or 400 per day as well as 20kr per every 10km.** If refueling is required during the renting period, a receipt can be submitted to Consensus for repayment of petrol.
- 2.5 The rentee is responsible for the cost of any damage caused to the car during the renting period, which is not covered by the car's insurance. Any deductible and fines for traffic violations are paid by the rentee.
- 2.6 In cases where assistance must be called, the rentee pays all costs incurred.
- 2.7 Other costs such as congestion tax are paid by the rentee.
- 2.8 The car should not be driven to transport intoxicated people.
- 2.9 Smoking, consuming alcohol, or transporting animals is strictly forbidden in the car. The car must be returned in good condition, and all possible debris must be cleaned out of the car after use. If the rentee violates this section, Consensus has the right to charge the rentee a fee of SEK 500. The rentee is also responsible for the other costs that may arise in the event of a breach. In the event of repeated violations and/or repeated inappropriate behavior, the Board may refuse to lend a person/organization a Consensus car. If the rentee does not find the car in good condition at the beginning of the loan period, this must be reported to the Consensus car manager as soon as this is discovered. If this is not done, the rentee will be responsible for any debris found in the car after the end of the loan period, regardless of how it got there, and will be charged as above.
- 2.10 The rentee must consider that they represent the union when using the Consensus car. This means that reckless and irresponsible traffic behavior can damage the Consensus' reputation and be punished when the board seems necessary. This applies throughout the rental period even when the car is not being driven, for example, parked. Based on this, Consensus assumes the right to charge the rentee a penalty fee, up to SEK 1,000, if Consensus finds that the rentee has violated section 2.10. If there are additional costs for Consensus due to what is stated in section

- 2.10, Consensus undertakes the right to charge the rentee for the cost incurred and in addition a penalty of up to SEK 1,000.
- In special circumstances during the reception period, organizers who are subject to 2.11 Consensus may be allowed to rent for a discounted price. Each case is treated individually.

3. AGREEMENT TIME AND TERMINATION

- 3.1 Consensus has the right to cancel the booking without notice, if it takes place within 48 hours from the beginning of the rental period, a reason must be given.
- 3.2 The rentee has the right to cancel renting the car up to 48 hours before the start of the rental period through contact with the signatory. If later, signatories may be invoiced.
